

First Vice President Joel Kay

According to the position description of the 1st VP, one of the responsibilities is covering the Districts east of the Mississippi River. There is only one matter regarding this portion of the country - Hurricane Sandy and its devastation to the yacht clubs and marinas in New Jersey, New York and Connecticut. Actually, I am more concerned about our members in these Districts, and the boaters who ply the waters there, in general.



I do not like to quote numbers; Marshall has the ability to make numbers interesting and/or use them as a subject for concern. I do not. But, for the record, to show what this storm did to low-lying areas along the coasts of Long Island, New York City, Staten Island, all of New Jersey and Connecticut, I am quoting some numbers that to me are astounding.

Connecticut: 2,500 boats damage; losses - \$23m marinas damaged: 20-25.

New York: marinas seriously damaged: 300-400

New Jersey: boats damaged - 25,000; boating losses: \$242m marinas seriously damaged: 80-120.

Boat US provides that for more accurate information, multiply the numbers by 300, especially regarding marina losses! The account of devastation is from data that needs further updating (USCG and BoatUS).

For our purposes, the area covered is located in Districts 12, 20, 22 and 26. This is a large area of Blue Gavel activity, active or otherwise. In order for this august body to ease the burdens of our members in these Districts, there has been considerable email, and some telephone discussions about the Blue Gavel's involvement. I firmly believe that we need to address the issue & put some money into the program. My problem is that I admittedly do not know where to begin the debate, or estimate its ending. I am, to quote a line from a wonderful old movie, "asking a higher authority to determine if Santa Claus really exists."

The insurance industry, particularly Boat US Insurance, has been performing a yeoman's job in settling claims. My opinion is that we need to set a policy, then an amount and then determine who/what entities would benefit the most from our involvement.

On a lighter note, our travel distance from our apartment on Siesta Key is so close, that I will not be submitting a travel voucher! Further, we have an IOBGA member staying in our guest suite for this event! Had I not gotten involved in this wonderful organization, I would not have had the many occasions to meet terrific people.

As stated in the bylaws, under duties of the second Vice president, "The Second Vice President shall be responsible for assisting the President and for public relations, the IOBG brochure, Area Vice Presidents west of the Mississippi River and the Director of District 51. The Second Vice President reports to both the President and the President Elect."

The last member from District 8 to be elected to the International Executive Committee was Ray Thompson in 2006 I recognize the amount of work and dedication that following in his footsteps requires. I look forward to working with President Chuck Browning and the other officers on the executive committee.

I attended the District 8 Winter Regional Meeting that followed The International Meeting at Venice Florida. I asked the District 8 members to remember that lines of communication between the Districts and International are better than ever, and International will answer every inquiry, and stand ready to assist the districts in every possible way when asked. It is always good to hear from individual members and chapters, and if you want to ask for a change in the bylaws or policy, you need to take it to the district members as a whole, and get a resolution passed in favor of your proposal at a District Membership Meeting, first. Your District Director can then take the proposal to the Board of Directors at the next Annual meeting.



I am also the liaison officer for the IOBG Auxiliary. Don't make the mistake and call them the "Ladies Auxiliary" A member is a spouse of a member, or a widow or widower of a former member and can be and often is, male. As the late Past Commodore Ken McLeod said when he held the office of 2nd International Vice President, "If your district doesn't have an active and involved auxiliary, you need to start one! I have found it amazing the difference that an involved Auxiliary makes. Almost without exception, every successful district will also have an active supportive and successful Auxiliary. It can only return benefits such as maintaining and increasing membership, harnessing a potent resource, and broadening the pleasure and enjoyment of Blue Gavel membership."

The District 8 Chapter at Coral Ridge Yacht Club has new life...

On Oct 23, 2012 I received a message from Past President Steve Willing forwarding an inquiry from p/c Charlie Sanmarco of Coral Ridge Yacht Club. The message was – "The Coral Ridge Yacht Club would like to become more active with membership in the IOBG. We currently don't think any of our active member P/C's are enrolled....How do we proceed?"

Steve asked me to respond, after telling me something I did not realize: "If the club had a chapter but all the members dropped out, and if one P/C wishes to join under the still existing chapter, then he can, without the other P/C's invitation. He only has to meet the qualifications as a P/C to become a member. There is no one remaining in the chapter to invite him."

P/C Sanmarco was sent an application which he quickly submitted and just as quickly received his membership card.

He invited SEVP and District 8 Director Lenworth Gordon to come to their Fleet Review and Officer installation on Sunday, January 27, 2013 where he could meet most, if not all, of the P/C's along with the new Commodore and other officers. Lenworth attended and took video of the event, which he included in his report at the Venice regional meeting. Coral Ridge Yacht Club now has 6 new members in their chapter.

Treasurer Marshall Nemoy

I presented the treasurer's report at our regional meeting held February 9, 2013 at the Venice Yacht Club in Venice, Florida. Here are some of the highlights of the report:

For the year ended December 31, 2012, IOBG had a net income of \$9,807 which was \$9,797 greater than budgeted but \$575 less than last year. Our revenues were \$1,569 less than budget but our expenses were \$11,366 lower than budget. The Annual Meeting, Area Vice Presidents and the Blue Gavel Log expenses accounted for the bulk of the favorable results.

Our total assets increased by \$9,358 to \$122,675. New this year was the addition of a special printer to print the new plastic membership cards. We also had more members pay their 2013 dues in advance. The deferred income this year is \$2,100 greater than last year. Overall our financial position remains strong.

For 2012, the primary reason for this year's profitability is we did not spend the money we had budgeted. As noted above, the significant positive budget variance should be viewed with the much lower year to year variance of \$575 to better understand this year's results. The areas of Annual Meeting and Blue Gavel Log must be budgeted as though a certain scenario will happen. If the expected results do not occur, the variance may be large. In this case not as many people attended the Annual Meeting and not as many members requested printed copies of The Blue Gavel Log. The 2013 budget has been adjusted accordingly.

The membership statistics shows the number of paid members as of February 4, 2013 to be 1,042 which is 10 more than we had at this time last year. Dues payments are arriving every day. Most of the variances are normal for this time of year. The report to be presented at the Spring Regional Meeting in June will provide a more clear picture of the membership situation.

Some other items noted in my report: Dues collections are steadily arriving in my office. The new plastic membership card takes longer to produce but we have worked out a process to get the cards out to members in a reasonable time. Some things to remember when sending dues transmittals: (1) make sure you provide all information for new members. We can not produce a card without a mailing address. (2) We need the full chapter name, not the initials. Please spell out the name. (3) Make sure the chapter name for the member is correct. We have been getting data with the wrong chapter name. (4) Alert us to a change of address. When we are working with 100 items we may not notice a change of address until the card comes back in the mail.

At the Annual Meeting we presented various designs for the new plastic membership cards. One design was selected and that is what is being sent to members. So far the comments all have been positive. It costs a little more to produce a membership card but I believe it is worth it.

Next year it is planned that the design will change. We are working on a plan whereby the members can participate in the process but I will leave that for ATS (after tax season).

We always need up-to-date email addresses. That is the primary delivery method for The Blue Gavel Log and the Lighthouse.

The US Sailing Board of Directors, with the affirmative vote of the House of Delegates, has passed a series of bylaws and regulations in an effort to reorganize their leadership structure. The reorganization is designed to more effectively serve members through streamlined communications between the board, committees and members. Highlights of the reorganization are: the House of Delegates has been retired, the councils were transitioned into new



committees and new composition has been established for the Nominating and Governance Committees, and the Board of Directors nomination process has been revised. There will be no more contested elections.

US sailing is accepting nominations for its 2012 Rolex Yachtsman and Yachtswoman of the Year awards, widely acknowledged as the foremost individual sailing honors in the nation.

US Sailing, the national governing body of the sport, has agreed on a multi year sponsorship deal with Sunsail and The Moorings, two leaders in water sports vacations and Yacht chartering.

The US Disabled Sailing Championships hosted by San Diego's Southwestern Yacht Club wrapped up another successful edition on North San Diego Bay's Americas Cup Harbor. Titlists were crowned in three championship fleets in single-, double-, and triple handed racing.

Miami, Florida held the ISAF Sailing World Cup at the US Sailing Center Miami January 26 to February 2, 2013. The regatta will form part of the ISAF Sailing World Cup until 2016 as the second stop in the 2012-2013 series.

US Sailing's 2013 National Sailing Programs Symposium was held in Clearwater, Florida January 23-26. The Symposium brings together more than 250 sailing instructors, program directors, volunteers, executive directors and industry leaders.






We welcomed Southwestern Vice President Rosalie Green to our meeting and appreciated her words of encouragement as the new year launches.

We are planning a spring brunch and hope this is another way to promote the camaraderie of the organization.


Many of the Chapters in District 9 are very active with projects to help support their clubs, as well as, humanitarian projects.




Rocks Yacht Club. Each of our clubs is situated at the upper portion of the Chesapeake Bay. As many of our sister clubs along the outer eastern shore of the United States, we were affected by Hurricane Sandy. At my home club Otter Point the club house lower level was under two feet of water and we lost much of the furniture there. Several of the boat owners suffered wind damage to canvas and deck equipment. Somewhere floating on the Bay is my new front deck five-foot lounger cushion that Sandy blew away. I just had it made at the beginning of this past summer. Do not get me wrong, I am not complaining in the least. When I see and hear of the devastation that the home and club members of New York and New Jersey have suffered I can only count my blessings and thank my almighty for them.

In June of this past year District 27 in collaboration with the Humanitarian Foundation sponsored a Sail-abration Fundraiser. It was the Bicentennial Celebration of the War of 1812 when the British Fleet attacked Fort McHenry and the Star Spangle Banner was written by Francis Scott Key. Many of the worlds most famous Tall Ships and US Military ships sailed from Norfolk, VA into the Baltimore Harbor. Among those ships was the United States Coast Guard Tall Ship "Eagle". We were able to gather twenty-five Wounded Warrior Veterans from Walter Reed Hospital and local VA Centers to sail on the Eagle from the US Naval Academy in Annapolis to the Port of Baltimore. We auctioned off two additional seats on the cruise for \$20.00 per chance and raised over \$2,000. The profits were donated to the Humanitarian Foundation; The Queen of the Chesapeake's...Save the Bay Fund;...and the Maryland Wounded Warrior Fund.

Many of the club members in Districts 12, 22 and 26 have lost boats, docks, clubs and in several cases homes. For this reason I would like to recommend that IOBG and the Humanitarian Foundation consider some financial help to those clubs that have suffered catastrophic losses. In this way we will be letting them know that in a small way we share their loss.
